Eligibility :-

Only one Next of Kins (NOKs)/dependents of ASSAM RIFLES personnel who were KILLED IN ACTION, DIED WHILE IN SERVICE, DISCHARGED FROM SERVICE ON MEDICAL GROUNDS AND MISSING WHILE ON SERVICE ARE ELIGIBLE TO APPLY FOR COMPASSIONATE GROUND APPOINTMENT.

- Dependent family members of following categories of Assam Rifles personnel are eligible to apply for Compassionate Ground Appointment:-
 - (a) Priority 1. Is killed in action (Martyred). (a) Priority 2. Dies while in service (including death by suicide). (b) Priority 3. Is retired on medical grounds under Rule 2 of the CCS (Medical Examination) Rules 1957 or the corresponding provision in the Central Civil Service Regulations before attaining the age of 55 years (57 years for erstwhile Group 'D' Govt servants). (c) Priority 4. Is retired on medical grounds under Rule 38 of the CCS (Pension) Rules, 1972 "Invalid pension may be granted if a Govt servant retires from the service on account of any bodily or mentally infirmity which permanently incapacitates him for the service "or the corresponding provision in the Central Civil Service Regulations before attaining the age of 55 years (57 years for erstwhile Group 'D' Govt servants). (e) Priority 5. Is medically boarded out and is unfit for civil employment. (f) Priority 6. Missing Assam Rifles Personnel While on Service. Cases of missing Assam Rifles personnel are also covered under the scheme for compassionate Ground appointment, subject to the following conditions:-
 - (i) A request to grant the benefit of compassionate ground appointment can be considered only after a lapse of at least 02 years from the date from which the Government servant has been missing, provided that:-
 - (aa) An FIR to this effect has been lodged with the Police. (ab) The missing person is not traceable (after police investigation report). (ac) The competent authority feels that the case is genuine. (ii) This benefit will not be applicable to the case of a Government servant:- (aa) who had less than two years to retire on the date from which he has been missing; or (ab) who is suspected to have committed fraud, or suspected to have joined any terrorist organisation or suspected to have gone abroad. (iii) Compassionate ground appointment in the case of a missing Government servant also would not be a matter of right as in the case of others and it will be subject to fulfillment of all the conditions, including the availability of vacancy, laid down for such appointment under the scheme; (iv) While considering such a request, the results of the Police investigation will also be taken into account. (v) A decision on any such request for compassionate ground appointment will be taken by this Directorate.
- Dependent Family Members: The following constitute Dependent Family Members:-

 - Married/unmarried Son (including adopted son), or
 - Daughter (including adopted daughter), or
 - Brother or sister in the case of unmarried Govt employee who was wholly dependent on him at the time of death in harness or retirement on medical grounds, as the case may be.
- 5. Cut Off Date for Reckoning of Age Limit. Cutoff date for calculation of upper age limit will be 01 Jan 2018 for fresh applications.
- 6. Time Limit of Application. Applicants who have already submitted their application to this Directorate need not to apply again and if found genuine CALL LETTER will be issued accordingly. However, such candidates should ensure that all documents as mentioned in the application will be produced by the candidates on reporting to the rect rally site.
- 7. PHYSICALLY HANDICAPPED ARE NOT ELIGIBLE.
- 8. APPLICATION FOR COMPASSIONATE GROUND APPOINTMENT" be endorsed on top of the postal envelope in which the application is being submitted.
- 9. Pay Scale. Pay scale and other allowance will be as admissible to Assam Rifles Personnel.
- 10. Rejection of Applications. Applications received after the last/due date will not be entertained and summarily rejected. Incomplete application, in any respect will be rejected summarily and no correspondence will be made on this account.
- 11. Vacancies are tentative and may increase or decrease. The vacancies so notified are subject to variation and the Department has right to make any change in the advertisement or cancel it without assigning any reasons.
- 12. Candidates to undergo Physical Fitness Test at own risk and expense. Injuries including fatal due to the test during recruiting rally will not be compensated in any manner. The candidates will have no claim what-so-ever against the Govt/
- 13. Those not in possession of required documents will not be permitted for the Rect Rally.
- 14. All certificates like Education/Permanent Residence /Nativity/Domicile/ Caste

- etc submitted by candidates during Rect Rally will be verified during pre-enrolment verification. In case of fake/forged documents/ certificates, FIR will be lodged for fraudulent enrolment and candidate will be handed over to State Police, besides his candidature being cancelled.
- 15. The following relaxation in physical attributes are applicable to the eligible candidates under "Compassionate Ground Appointment scheme".

- 16. Selection of candidates will be PROVISIONAL even after passing successive stages of screening for recruitment till completion of all the pre-enrolment validation
- 17. Overcrowding. To avoid over-crowding, only candidates will be permitted to enter Rect Rally Site: Parents/friends are advised not to accompany candidates. Candidates will not be permitted on any other date less the one mentioned on the call letter.
- 18. Medical. Successful candidates in Physical Standard Test/Physical Efficiency Test, Documentation, Biometric and Trade Test (Skill Test) will undergo medical examination on the same or next day at the Rect Rally site. Decision of medical fitness by Assam Rifles Medical authority is final and binding.
- 19. Candidate must carry their AADHAR Card which may be authenticated biometrically at the rally site, failing which; the candidate will not be screened for recruitment. Ensure AADHAR details are matching with the details mentioned in the other documents submitted by the candidate.
- 20. How to Apply. Candidates shall submit their applications as per format attached alongwith self attested copies of educational certificate, domicile certificate, caste certificate, diploma/technical/ITI certificate of the trade in accordance with qualitative requirement, incl Aadhar, PAN to the address mentioned below:

Relaxations:-

- (iii) The minimum height of candidates falling in the categories of Garhwalis, Kumaonis, Dogras, Marathas and candidates belonging to the States of Assam, Himachal Pradesh and Jammu & Kasmir will be 165 cms for male and 155 cms for females.

Chest :- (i) The minimum chest for all male candidates belonging to Scheduled Tribes will be 76 cms (minimum 5 cms expansion)

- (ii) The minimum chest of male candidates falling in the categories of Garhalis, Kumaonis, Dogras, Marathas and candidates belong to the States of Assam, Himachal Pradesh and Jammu & Kasmir will be 78 cms (minimum 5 cms expansion)
- (iii) The minimum chest of male candidates hailing from North-Eastern States of Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Skkim & Tripura and Gorkha Territorial Administration (GTA) as mentioned in para 5(b)(iv) above will be 77 cms unexpanded (with minimum 5 cms expansion)

- (iii) Minimum height for candidates belonging to Scheduled Tribes (ST), Height 162.5 cms (male), 150 cms (female), Chest (Male) Unexpended 76 cm, Expended -81cm, Weight - For male and Females: proportionate to ht and age as per medical standard.
- (c) Havildar (Clerk) and Warrant Officer (PA). (i) For all candidates except ST candidates, Height-165 cms (male), Chest (Male) unexpended - 77 cms, Expended-82 cms, Weight - Proportionate to height and age as per medical standard.

- Physical Efficiency Test. The physical efficiency test (PET) will be conducted for all trades including General Duty, Technical, Tradesmen, Clerk & Personal Assistant as under:-
- (a) For Male Candidates 05 Km run to qualify within 24 minutes.
- (b) For Female Candidates 1.6 Km run to qualify within 8.30 minutes.
- Trade Test (Skill Test). Trade test (Skill Test) for technical & tradesmen personnel including clerk & personnel assistant will be conducted before undergoing Detailed Medical Examination (DME). No marks will be awarded. Candidates will be assessed as Pass or Fail. Candidates who pass the trade test will only be undergone for Detailed Medical Examination.
- 25. Detailed Medical Examination and Review Medical Examination. Detailed medical examination (DME) and review medical examination (RME) will be undergone as per guidelines issued by ADG (Medical) CAPF, NSG & AR dt 20 May 2016.
- Written Test. Candidates who are applying under the scheme of COMPASSIOANTE GROUND APPOINTMENT will be exempted from WRITTEN EXAM TEST.
