- ❖ Candidates must not be less than **18 years** or more than **43 years** of age as on 01.01.2019. In appropriate cases, relaxation of age will be admissible as per existing rules of the government of Assam.
- ❖ Candidates must have **passed Class VIII**.
- ❖ One self-addressed envelope of 5cm X 11cm affixing postal stamp of Rs. 5/- (Five) is to be enclosed with the application along with the mobile number, if any.
- ❖ Candidates intending to apply for different posts shall submit separate applications for each post.
- ❖ Applicants those who are already in service should submit their applications through proper channel with No Objection Certificate from his/her employer.
- ❖ The applicants who will apply for the post of driver and whose applications are found in order will be Called for **Driving test** to be held at a place and date to
