- 4. Age relaxation for SC/ST/OBC/PWD candidates will be as per Govt. of India/ICMR rules. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. Age relaxation may be considered for deserving candidates under ICMR rules.
- 5. Candidates having master degree in other subject with working experience in operational research project in the field of Kala-azar may also be given due consideration.
- 6. Appointment will be on contractual basis for a period of one year. However, appointment can be extend for another one year or till the end of project, whichever is earlier based on the progress of the project.
- 7. Candidates will have no claim in future for employment under the Institute/ICMR services.
- 8. During the appointment, if performance of the appointee is not found satisfactory by the competent authority, appointment can be terminated anytime without any Notice.
