- 3. Candidates already employed in Govt. /PSU must submit their application through proper channel or submit a 'No Objection certificate (NOC)' from their employer. Such candidate may submit an advance copy of their applications online but their candidature shall only be considered if the applicants submit their NOC/receive proper channel application within 10 days after closing date of online application. Those who apply for appointment on deputation should submit the applications along with vigilance/integrity certificates and attested copies of their Annual Performance Appraisal Reports (APAR) for the preceding five years.
- 4. It may be noted that mere possessing of the prescribed qualifications and requisite experience would not entitle a person to be called for interview. Only the shortlisted candidates will be invited for interview.
- 5. Canvassing in any form will be a disqualification. Postal delay shall not be entertained.
