### General Instructions to the Candidates

1. Online mode of submission of applications shall be essential.
2. Applicants shall first register on the Recruitment portal on the AUS website, after which, they can fill up the prescribed electronic application form online.
3. Before starting to fill up the form, please ensure keeping ready a digital copy of passport size photograph in JPEG format not exceeding 50 kb in file size and digital copy of signature not exceed 50KB, for up-loading.
4. Filling all mandatory fields is required to make your application complete.
5. Incomplete applications will not be considered and will be REJECTED.
6. While filling the online application, if your browser closes unexpectedly or if you are logged out, please use the login information sent to your email to login again.
7. In case of any technical problems, please send an email to [recruitmentaus2017@gmail.com](mailto:recruitmentaus2017@gmail.com).
8. There are several Tabs in your application. After completing each tab, you should click on "Save and Proceed" button to save the information and move to the next tab. After filling of all tabs, the candidate can finally submit his application. **Please note that you cannot make any changes after final submission.**
9. On successful submission, the applicant will come across a link to download a PDF of the application, which he/she will have to print and keep it in safe custody, this printed application will required to be presented at the time of personal interview.
10. Mere eligibility will not entitle any candidate for being called for interview. More stringent criteria including holding written test may be applied for short-listing the candidates to be called for interview. Applicants having higher qualification and merit or higher marks in the written test will be given preference.
11. Applicants who are in employment should route their application through proper channel or should submit a "No Objection Certificate" from the employer prior to the interview, failing which they may not be considered further.
12. Candidates are advised to satisfy themselves before applying that they possess at least the minimum essential qualifications laid down in the advertisement.
13. The eligibility of the candidate will be reckoned on the last date of submission of application i.e., **31.05.2025**.

**1. For the post of Chair Professor :**

- (A) (i) An eminent scholar with Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2. **(Specialization in Dr. Ambedkar's Thought & Philosophy/ Education, Social justice/Inclusion/Harmony is desirable).**
- (ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institution with evidence of having successfully guided doctoral candidate.
- OR
- (B) An outstanding professional, having Ph.D. Degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above)/ industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

## **GENERAL CONDITION & ESSENTIAL INFORMATION**

1. The medium of instruction in the University is **English**.
2. Candidates should go through the Employment Notifications carefully before applying for a particular post and ensure that they fulfill all the eligibility conditions like Essential Qualifications (EQs)/Experience/Category/API Score, etc. as indicated in the respective eligibility Notifications. **Candidature of candidates not meeting the eligibility conditions will be cancelled at any stage of the recruitment process without any notice. Candidature of Applicants shall be purely PROVISIONAL at all stages of the recruitment process.**
3. As per Ministry of Human Resource Development Notification dated 10-06-2015 published in Gazette of India all the degrees/diplomas/certificates awarded through Open and Distance Learning mode of education by the Universities established by an Act of Parliament or State Legislature, Institutions Deemed to be Universities under Section 3 of the University Grant Commission Act 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services under the Central Government provided they have been approved by the University Grants Commission. **Accordingly, unless such Degrees are recognized for the relevant period when the candidates acquired the qualification, they will not be accepted for the purpose of Educational Qualification. As per UGC (Open and Distance Learning) Regulations, 2017 published in official Gazette on 23-06-2017, under Part-I (2)(p), the programmes in engineering, medicine dental, nursing, pharmacy, architecture and physiotherapy etc. are not permitted to be offered under Open and Distance Learning mode.**
4. Applications incomplete in any respect and not accompanied with relevant certificates/documents/photographs/copies or orders etc., as desired or without registration fee will be summarily rejected.
5. Candidates are advised to satisfy themselves before applying that they possess essential qualifications laid down in the advertisement.
6. Candidates already in employment would be required to submit their application through proper channel, failing which they may not be considered. However, they may send an advance copy and produce 'No Objection Certificate' at the time of interview.
7. Mere eligibility will not entail any candidate for being called for interview. Applicants having higher qualification and merit will be given preference.
8. As far as possible preference may be given to the persons belonging to SC, ST, OBC or those belonging to other Weaker Sections of the Society in the selection of above posts.
9. The candidates will be called for interview, wherever applicable, by the University on the recommendations of the Application Screening cum Scrutiny Committee.
10. Experience and qualification will be reckoned as on the last date of submission of online application.

11. The University shall verify the antecedents or documents submitted by the candidate within three month of the joining. In case, it is detected at any time that the documents submitted by the candidates are fake or the candidate has clandestine antecedents / background and has suppressed or altered the said information, then his/her services shall be terminated immediately and appropriate action shall be initiated as deemed fit.
12. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves right to modify/withdraw/cancel any communication made to the candidate.
13. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
14. Candidates must enclose self-attested copies of certificates and mark-sheets from matriculation (10<sup>th</sup> Standard) onwards in support of their qualifications and reprints of publications and certificates in support of their claim for the post along with the application form.
15. Canvassing in any form will be a disqualification.
16. No interim correspondence shall be entertained.
17. In case of any dispute, suite or legal proceedings against the University, the jurisdiction shall be restricted to the Hon'ble High Court of Gauhati, Guwahati.
18. The service contract may be terminated at any time with one month's prior notice by the university or one month salary may be paid in absence of notice without assigning any reason. The candidate is also required to give one month's advance notice or else deposit one month's salary; in case the candidate is leaving during the contract period.
19. After joining the positions under Dr. Ambedkar Chair, the candidates will have to abide by the Act, Statute, Ordinances, Regulations and Rules, of the University/Rules of UGC/Rules of Government of India applicable from time to time. S/he may be assigned any duty within/outside the University depending upon the exigencies of the work.
20. The selection procedure for Chair Professor shall be as laid down by the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic staff in Universities and Colleges and Measures for maintenance of Standards in Higher Education, 2018 and as amended from time to time (Amendment Regulations, 2021 notified Oct. 12, 2021 in Gazette of India).
21. A Relaxation of 5% may be provided for the teaching posts at the Graduate and Master's level for the SC/ST/Differently-abled (Physically and visually differently-abled)/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark.
22. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. degree

holders, who have obtained their Master's Degree prior to 19th September, 1991.

23. Candidates awarded degree by Foreign Universities is required to submit Equivalence Certificate issued by the Association of Indian Universities, New Delhi.
24. Only online applications will be accepted, which can be filled/downloaded from University website [www.aus.ac.in](http://www.aus.ac.in). No printout of application is required to be sent or submitted to the University

**SPECIAL INSTRUCTION:**

25. Caste Certificate: The candidates should clearly state to which category they belong. They should also enclose a certificate issued by competent authority as proof to this effect, without which the application will not be considered.
26. Candidates seeking reservation benefits available for SC/ ST/ OBC/PWD/ EWS/must ensure that they are entitled to such reservation as per eligibility prescribed. They should also be in possession of the certificates in the prescribed format in support of their claim. Candidates with **benchmark physical disability** only would be considered as Persons with Disabilities (PWD) and entitled to reservation for Persons with Disabilities.
27. The income criteria to exclude socially advanced persons/sections (Creamy Layer) from the purview of reservation for Other Backward Classes (OBCs) shall be as prescribed vide, GOI, DoPTs O.M. No 36033/1/2013-Estt(Res) dated 13.09.2017.
28. Candidates belonging to OBC should submit an attested copy of OBC certificate/Creamy Layer exclusion in the prescribed form issued by the Competent Authority; vide Column 3 of GOI, DOPT's O.M. No. 36036/2/2013 dated 30.05.2014 without which applications will not be considered.
29. Candidates belonging to PWD, should submit an attested copy of certificate of disability in the prescribed form issued by Competent Authority, in accordance to the GOI, DOPT's OM No. 36035/3/2004-Estt(Res) dated 29<sup>th</sup> December, 2005.
30. Candidate belonging to Economically Weaker Sections (EWS) should submit an attested copy of **Income & Asset Certificate** in the prescribed format (Annexure-I) issued by the Competent Authority; vide Column 5 of GOI, MP, PG & P, DOPT's OM No 36039/1/2019-Estt(Res) dated 31<sup>st</sup> January, 2019.
31. No subsequent change or request for change of category will be entertained under any circumstances.

**IMPORTANT NOTE:**

32. Candidates who will attend the interview for the post of Professor/Associate Professor and or equivalent will be reimbursed AC III tire train fare through shortest route and those who will attend the interview for the post of Assistant Professor will be paid Sleeper class train fare through shortest route on production of relevant tickets only. Bus fare shall be reimbursed only if there is no rail connectivity.
33. Certificate in support of experience shall be in proper format i.e. it shall bear the organization's letter head, bear the date of issue, specific period of work, name and

designation of issuing authority along with signature and official seal.

34. The University will not be responsible for postal delay in any correspondences with the applicants/candidates. No correspondence no telephonic/electronic query will be entertained from candidates regarding postal delay, conduct and result of interview and reasons for not being called for interview. Canvassing directly or indirectly at any stages of the recruitment process will lead to disqualification.
35. Appointment to the post of Chair Professor Shall be made by following the same procedure as followed in respect of regular Professors in the University as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018
36. The Chair Professor will be recruited in accordance with the Statutes, Rules and Regulations followed by the concerned Universities/Educational Institutions in this regard keeping in view the conditions stipulated under the Memorandum of Understanding (MoU) entered between Dr. Ambedkar Foundation and the concerned Universities/Institutions. The posts of Professor will be for 5 years, and hence the persons working against each post will be treated on par with regular staff in the University/Educational Institution for all purposes.
37. In respect of service matters, the staff functioning under the Chairs shall be governed by the Rules and Regulations and Statues followed by the University/Institution in this regard.
38. Anything not covered above shall be decided based on the provisions of Assam University Act, Statute, Ordinances, Regulations, UGC Regulations and MHRD, GOIs Guidelines/Orders.
39. **Candidates/Applicants are advised to visit the university website frequently for updates/addendum/corrigendum/list of shortlisted candidates etc.** Any change/additions/ addendum will also be notified in the University website only.
